The holder of the power of attorney is also entitled to represent the donor of the power of attorney before the courts, public authorities, in particular to receive and to make declarations, including waivers and admissions, receive notice of service, file for, withdraw and waive legal remedies and appeals, conclude settlements, and to appoint representatives itself.

The power of attorney also applies to collateral proceedings, such as attachment, seizure and temporary injunctions, as well as taking evidence, determining costs and collecting sums due.
